Abstract

The abstract should contain information on the key content of your paper and include key results and conclusions of your work. It should not be longer than 500 words. Use only one level of heading and do not use subheadings in the abstract. Do not place references in the abstract. (Abstract: Times New Roman, Justified, Italic, 11 pt)

Keywords: 3 to 5 keywords here, separated by commas (Keywords: Times New Roman, Regular, Aligned Left, 11 pt)

1. Introduction (Headings: Times New Roman, Bold, Aligned Left, 12 pt)

This document provides guidelines for preparing papers for the World Renewable Energy Congress XVI, at Murdoch University, Perth, Western Australia. Authors are advised to use this template in order to maintain a high standard of the conference proceedings. (Main text: Times New Roman, Regular, Justified, 11 pt)

2. Methodology

The maximum length of full papers is six pages including text, references, figures and tables. Any extra pages will be deleted in the proceedings. The paper size should be set to A4 (21.0 cm × 29.7 cm) and all margins should be set to 25 mm. The required type face is Times New Roman. All text should be fully justified in 11 pt regular face (style: Normal). Use 12 pt bold lowercase for main headings and leave an empty line between paragraphs.

All papers should include the following: Abstract, 1. Introduction, 2. Methodology, 3. Results, 4. Conclusions or Recommendations or Discussion, 5. References. Alternatively, the author may indicate in a covering email justification for different headings.

3. Results

Subheadings may be used within the main body of the text which is supposed to be in a single column format. Avoid long sentences.

3.1 Figures and tables

Figures and tables should be inserted into the text and be referred to within the text (Fig. 1, Table 1). They should be numbered and contain a caption. Furthermore, they should be placed as close as possible to their first mention in the text. Do not extend figures or tables into the margins. Both, figures and tables should be centred on the page.

SI units are to be used throughout the manuscript. Equations should be centred within the page, numbered consecutively and referred to within the text (Eq. 1).

4. Conclusions

Include concise conclusions / recommendations or a discussion in your paper. All papers have to be submitted via email to the editor, Dr David Goodfield, d.goodfield@murdoch.edu.au. Please remember to have the English grammar and spelling checked before submitting your paper. Note that commercialism (i.e. use of company or product names or logos in the text or illustrations) is not permitted. Upload the following publication files for the full paper submission:

- an MS Word version of the submitted abstract,
- an MS Word version of the full paper in camera-ready form,
- a PDF copy of the full paper in camera-ready form,
- a scanned signed copyright release form.

The deadline for submitting full papers is January 15th, 2017. The acceptance of the full papers for journal publication will be communicated to the contact author no later than February 22nd, 2017. Only those papers received by the deadline will be published in the conference proceedings CD-ROM.

5. References

References should appear in the text using brackets for the principal author and *et al* for subsequent authors (Batten, W.M.J. et al, 2008). All references should be listed in this section following the style given below in alphabetical order of the principal author. (References: Times New Roman, 10 pt)
